Andrea G. Ferrenz, Esq. works primarily with Campbell Soup Company's Government Affairs, Quality, Regulatory, R&D, and Marketing teams on some of the most iconic brands in the United States. Previous to her role at Campbell's, Andrea was an attorney with the law firm Emord & Associates PC in the Washington, D.C. area for many years, practicing food and drug law for clients primarily in the natural products industry. After private practice, Andrea was Executive Vice President, Legal Counsel with Celltex Therapeutics, a biological drug company in Houston, TX. After Celltex and prior to joining Campbell's Soup Company in 2017, Andrea was Regulatory Director, Associate General Counsel with Innophos, Inc, a manufacturing company supplying ingredients to the food, dietary supplement, pharmaceutical and technical industries around the globe.

Andrea has served on nonprofit boards as a volunteer as well as advised for-profit corporate boards in her professional capacity. In the 2010s Andrea was a voting board member-at-large of a community organization in Virginia and a member-at-large, then an officer, of her faith community's board. She was a nonvoting member of Celltex Therapeutics' board and advised Innophos' board on food law related issues. Also for three years, she

represented Innophos as a voting member on the boards of trade associations to which the company belonged: International Food Additives Council and the Council for Responsible Nutrition. Andrea's undergraduate degree is in Biology from University of Mary Washington, Fredericksburg, Virginia. Andrea began her career working in labs, first as a research assistant with the Institute for Genomic Research in Gaithersburg, MD, then with Children's National Medical Center, Center for Cancer and Transplantation Biology in Washington, D.C. During law school she was a legal intern with the U.S. Department of Health and Human Services Office of Research Integrity. A particular interest of Andrea's throughout her career has been the intersection of science and law.
