She studies cross-sector approaches to ensure that all children have stable access to healthy food environments at home and in their communities, enabling them to thrive and grow into healthy adults. Dr. Virudachalam serves the director of sustainable community health partnerships at the Community Health and Literacy Center in South Philadelphia and as the faculty lead for PolicyLab's Intergenerational Family Services portfolio.

Dr. Virudachalam holds a bachelor's degree from the University of California, Berkeley, a medical degree from the Pennsylvania State University College of Medicine, and completed her pediatric residency at UCSF Benioff Children's Hospital Oakland. She then completed an academic general pediatrics fellowship at CHOP and earned a Master of Science in Health Policy Research from the University of Pennsylvania.
